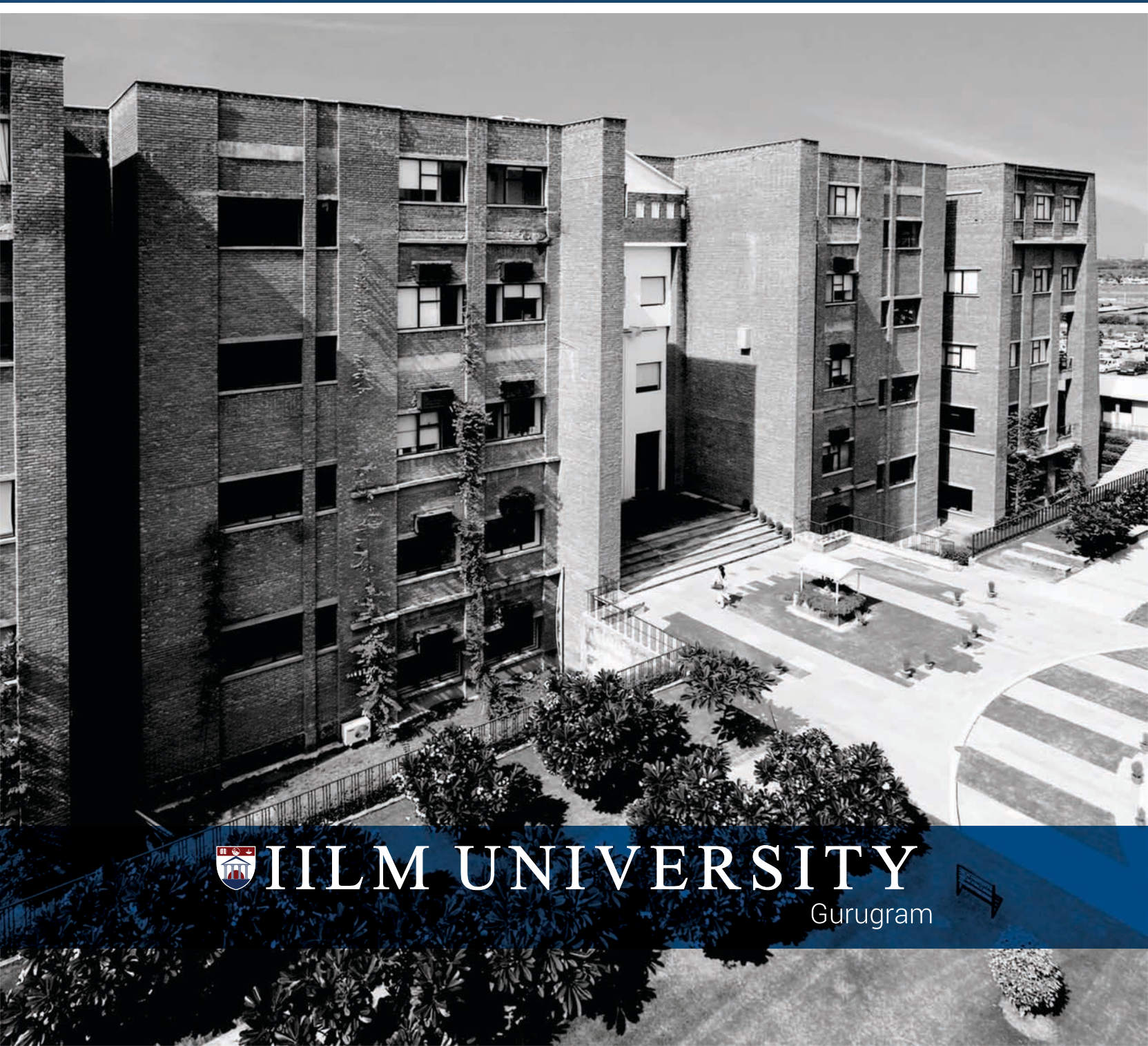

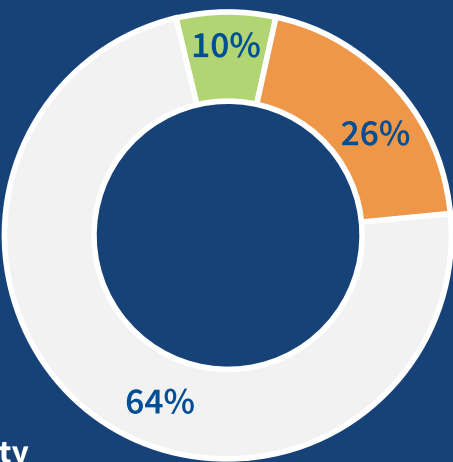
➡ LLM (Seven Specializations)

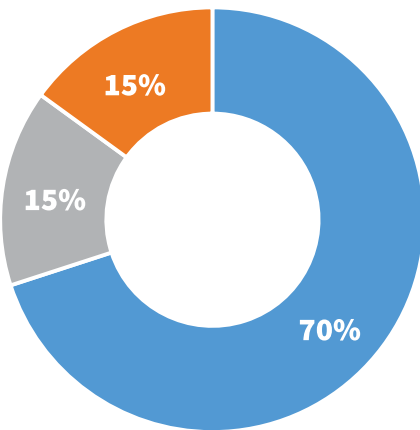


Curriculum Design

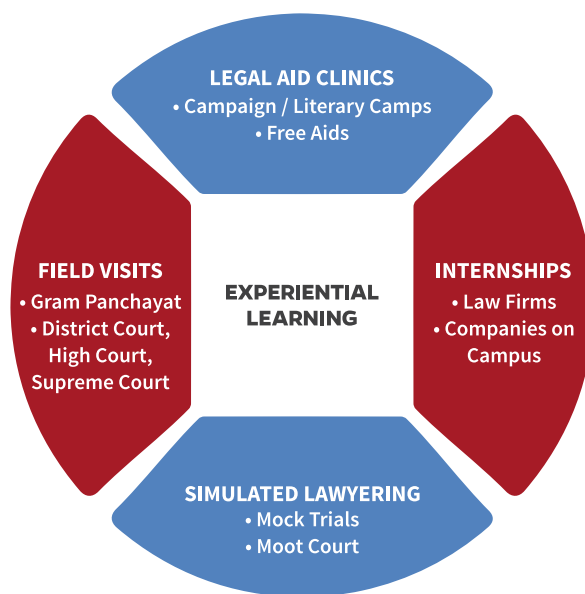

Admission Procedure

Admission to BA LLB (Hons), BBA LLB (Hons) and LLM First Semester is made based on the merit in qualifying examination and IILM Law Entrance Test followed by an interview. Candidates applying for Undergraduate programs with CLAT score of 100 or above are exempted from the IILM University entrance test. Candidates applying for LLM program need to clear the IILM Law Postgraduate Entrance Test.

Scholarships
