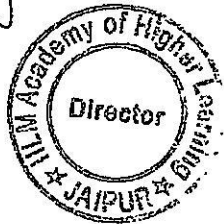


AIMs of PwD Support Committee:
